2. College candidates will receive their Detailed-Marks-Cards (DMC) through the Principal of their Institutions. In case of non-receipt candidates should write through Principal not direct.
3. All private candidates will receive the DMC within ten days from the date of declaration of the result. If any candidate does not receive the same within fortnight of the declaration of the result or any result remains 'RL' the candidate should write to Asst/dy. Registrar Tell. No. 238582 and EPABX- 2461.
4. No Application for original Detailed-Marks-Card/Certificates will be entertained after a period of three months from the date of declaration of result.
5. All enquiries regarding result should be addressed to Dy/Asst. Registrar (Exam-I) KU Kurukshetra.
6. Re-evaluation of Answer-book(s) in Theory paper(s) is permissible within 20 days of the date of publication of result or 15 days of dispatch of DMC by the University, whichever is later, on submission of Application form which can be had from the Manager, Printing and Publications KURUKSHETRA UNIVERSITY, KURUKSHETRA on payment of Rs. 10/- at the counter or by remitting Rs. 30/-, if required by Regd. Post. It must be accompanied by Original DMC and Re-evaluation fee of Rs. 300/- per paper. The application should be addressed to Asst. Registrar (Re-evaluation) Kurukshetra University, Kurukshetra - 136119, Telephone No. 2455 (University EPABX Exchange).
7. Examination Admission form can be had from the registered book-sellers of all the towns on the payments of Rs. 10/- per form or from the Manager, Printing and Publications Kurukshetra University, Kurukshetra - 136119 on remittance of Rs. 35/- (including Postage) per admission form.
8. University shall not be responsible for delay or misplacement of DMC's sent through UPC / Registered Post.
9. Only latest Examination Admission form which costs Rs. 10/- will be accepted, otherwise Fee & late fees will be charged.
